SAFETY INTERVENTION GUIDE

Safety in the 54SID is a state where everyone is free of harm, thrives, and has their well-being protected and their diversity celebrated.

COMMUNITY SAFETY COMMUNICATIONS

The 54SID uses three communications processes to alert 54SID employees, businesses, and property owners to safety incidents in the 54SID.

Safety Emergency Message

This message is intended for severe safety alerts in the 54SID. This will push out an emergency text followed by an email with more information.

Examples: Shootings, Kidnappings, Aggravated or Sexual Assaults

How: Call the 54SID Ambassador Hotline at 614.636.5100

Community Bulletin

This message is intended for alerts that are helpful information for businesses in the 54SID that is an attempt to help all parties involved.

Examples: A member of the community is in crisis, A gathering that might impact the 54SID

How: Email info@fifthandfourth.org or Call the 54SID Hotline at 614.636.5100

Slack Channel

This is an internal communications channel intended for businesses to communicate what they deem necessary information to share with other businesses. Guidelines will be provided to address bias in communications.

Examples: Theft, Property Damage

How: Post in the Slack Channel.



CALLING 911 EMERGENCY SERVICES

Community members are advised to call 911 Emergency Services when there is a risk to human life safety due to severe mental or bodily injury and it cannot be resolved with the community.

Examples of incidents that may require the need for 911 Emergency Services response may be an act of threat of violence (such as kidnapping, aggravated or sexual assult, other felonious acts, weather emergency, act of terrorism, or other disaster).

Consult the chart below to help determine if a call to police is the needed first safety intervention.
