Advocacy & General Community Engagement Update Safety

Status of Safety and Safety Programs was shared.

There was discussion of three shootings all after 3AM outside of the 54SID area that were all related to bar patrons and involved gunfire at random. Public safety funding has been requested to benefit the areas adjacent to the 54SID.

Various board members discussed causes related to violence and if there were any solutions from property owners or police. Leah Evans specifically inquired if the new chief expressed any interest in focusing on youth based programs that could head off any issues that may happen in the summer months and asked if it could include Parks and Rec but engages police to get youth involved in those programs before they are involved in violent incidents.

The board discussed ideas being offered regarding a good neighbor pledge program and expressed hope that the city will want to collaborate ongoing instead of just as a year-long program. The board discussed that the long term strategy is reorganizing precincts and CPD decisions and staffing/operations
